The Investment shares are non-voting, however, have a priority in dividend distribution, and are redeemable with prior notice/permission.
3. In order to apply for the Home Purchase Plan (HPP), you are required to open either a membership or investment account. Please see HPP regulations for details.
4. The parent or legal guardian can open a separate Investment Account(s) for their minor children/relatives on the same conditions as listed above. They will be responsible for operating the account on behalf of the minors, may deposit and withdraw funds by redeeming the shares by giving proper notice. However, the year-end T5 slips for the minor's dividend will be issued in the name of the parent/legal guardian.
5. In general, it is understood that the investment is for a long-term basis, i.e. more than one year, however depending on the situation this condition can be waived with a notice as required or being transferred to HPP.
